Rules and Regulations

Ride Times: Will be posted no later than 12:00pm on December 1, 2023 via showsecretary.com

Prizes: Ribbon's 1st -6th for all classes. High Point ribbons for (overall) high point Dressage, Western Dressage, and lowest point Combined Test. TIP high point for Dressage and Western Dressage and TIP lowest point Combined Test. Level High Point Champion Ribbons. TIP awards will be given based on scores received for the entire weekend. Team Competition will be award 1st-6th.

Attire: Neat and tidy. Anyone mounted must wear protective headgear. Boots/shoes worn while riding anywhere on the competition grounds should have a distinguishable heel. **ASTM Hard Hats/Helmets required when mounted.**

Equipment and tack: We will be adhering closely to the USEF equipment and/or tack requirements. Improper equipment/tack could result in disqualification. Notable Exceptions: polo wraps and/or boots and alternative hoofwear.

Arena: Combined Test ridden in a 20x40 meter dressage ring. Classical and Western dressage test ridden in a 20x60 meter dressage arena.

Jump Course: Jump course will be posted 30 minutes prior to show start. Courses will be set at show management's discretion.

Stalls: \$30 per night. Shavings are available at \$9 per bag.

Office Fee/Processing Fee: \$30 per horse

Late Fee: \$20 per entry (entries submitted between).

Change Fee: \$15 per change. This applies to any changes of horse/rider/handle and/or test/class.

Refunds: Prior to closing date, full refund MINUS OFFICE FEES and ONLINE convenience fees (if applicable). Show secretary must be notified prior to the closing date of the show. **No refunds will be issued after closing date (even if closing date is extended)** If the show is cancelled due to hazardous weather, Act of God, accident, or emergency the show will be rescheduled.

Children/Pets: Children must be supervised at all times. Dogs must be on leashes at all times while on showgrounds.

Entries and Payment: All entries must include coggins, entry sheet, entry fees, and properly signed hold harmless waiver. Entries can be received at showsecretary.com or mailed to Susan Peacock 837 Glenlake Dr. Edmond, OK 73013. Payment must be included when entries are submitted.

Accordingly, I/we agree that any activity engaged in, **hosted by Gulf Coast Chapter Chapter and/or DSDCTA**, on any premises related to horses, or horseback riding, is done at my own risk. Accordingly, I/we release and agree to hold harmless **the hosting venue, the featured teacher/judge/trainer/clinician, and/or the Gulf Coast Chapter Chapter and/or Deep South Dressage and Combined Training** along with its board of directors and employees, and any and all persons or entities who are guarantors or indemnitors of the above, all agents, employees, promoters, sponsors, other horse riders, horse owners, advertisers, sales persons, photographers, volunteers, (hereinafter called Releasees) from all liability for negligence or otherwise.

I/we agree not to sue any Releasees, and I/we release and agree to indemnify for the Releasees form and for all liability for the undersigned, his/her person, representatives, assignees, heirs, and demands therefore on account of injury to her person or property, or communicable disease, or death of undersigned whether caused by negligence of the Releasees or otherwise.

I/we have read and voluntarily signed the release and waiver of liability and indemnity agreement and further agree that no oral representations, statements, or inducements apart from the foregoing written agreements have been made no shall be made except by written and signed addendum
