Entries: Entries must be postmarked on or before the closing date. Entries postmarked after closing date will be considered post entry and will incur late fees. FOR SPECIAL DELIVERIES, PLEASE SEND ENTRIES WITHOUT A SIGNATURE NEEDED. NO CERTIFIED, REGISTERED, OR EXPRESS MAIL WITH A SIGNATURE NECESSARY FOR RECEIPT WILL BE ACCEPTED.

Online entry is available at www.showsecretary.com. No post-dated checks accepted.

Those entries postmarked after closing will be accepted at the discretion of the show secretary, based on space available basis and charged a \$30.00 late fee per show. If the classes are oversubscribed, a Waiting List (in order of receipt) will be maintained. Management reserves the right to refuse any entry.

JR/YR Division: Riders must be under 21 as of January 1, 2024 to compete in the JR/YR division.

Official Ride Times: Stabling assignments and provisional times will be available to competitors at www.showsecretary.com.

Refund Policy: Cancellations prior to closing date will be refunded, less office fee(s) and online convenience fees. No refunds will be given after closing date.

Hazardous Weather/Act of God/Accident Policy: Management reserves the right to cancel any classes due to hazardous weather, acts of God, accident, or emergency. Every effort will be made to reschedule with priority given to any qualifying classes being offered. No refunds for cancellations due to hazardous weather, acts of God, accidents, or emergencies.

Schedule: Classes may not necessarily run in the order listed on the prize list. It is the responsibility of the rider to inform the show secretary of any time conflicts as soon as possible after receiving the schedule. Management reserves the right to change officials, limit entries, combine or cancel classes, and modify the schedule, to modify or cancel awards and/or make whatever changes are required by circumstances to the competition specifications listed herein. Show management reserves the right to cancel classes insufficiently filled and to refuse or require withdrawal of any entry for cause deemed sufficient by show management.

Helmets: Protective headgear is **required** for all riders when mounted.

Scores: It is the responsibility of all competitors to verify the accuracy of all scores. Scoring errors must be reported to the Show Secretary within one hour of the official posting of the scores from the last class of the show day during which the score was earned.

Dogs: Well-mannered dogs on leashes or in crates are welcome

Facility: Masterfare Equestrian Center shares the facilities with a working cattle operation and asks that trailers and vehicles park in designated areas only to allow farm equipment full access to all areas of the farm. The show ring will be set up in the large outdoor arena (weather permitting) and the schooling area will be set up in the indoor arena. Lunging will NOT be permitted in the indoor arena (and the facility does not have an area available for lunging your horse). Riders will be asked to pick their horse's feet before (and after) entering the indoor arena to maintain quality of the footing. A negative Coggins' Test and liability releases should be included with your show entry.

Lead Line: Individual leading the horse/pony must be 18 years of age or older. The leading rein

should be attached to the cavesson, noseband, or halter while leaving control of the horse to the rider. Rider must wear a shoe with a heel and their feet must be in the stirrups. Riders and handlers must comply with helmet rules. Stallions may not participate in the leadline class.

Musical Freestyles: Sound checks will be scheduled with the show manager. Music files can be emailed to the manager at ameliaksmith07@yahoo.com by June 9th.

OHIO LIABILITY RELEASE AND ACKNOWLEDGMENT

I AGREE THAT: I choose to participate voluntarily in the **Mid-Ohio Dressage Association (MODA)** Spring Warm-Up Schooling Show. I am fully aware and acknowledge that horseback riding and equine activities carry inherent dangerous risks of accident, loss and serious bodily injury. In accordance with the Ohio’s Equine Liability Act, Ohio Revised Code 2305.321, **I do hereby acknowledge the following INHERENT RISKS OF EQUINE ACTIVITIES:**

- a. The propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine;
- b. The unpredictability of an equine’s reaction to sound, sudden movement, unfamiliar objects, person or other animals;
- c. Hazards, including, but not limited to, surface or subsurface conditions;
- d. A collision with another equine, another animal, a person or an object;
- e. The potential of an equine activity participant to act in a negligent manner that may
- f. contribute to injury, death, or loss to the person of the participant or to other persons, including, but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant.

I AGREE THAT: in consideration of the Mid-Ohio Dressage Association allowing my participation in Mid-Ohio Dressage Association’s hosted or sponsored activities, and/or any other equine activity, under the terms set forth herein, I, the rider, and the parent or guardian thereof if a minor, do (a) agree to hold harmless and release the Mid-Ohio Dressage Association, its, agents, volunteers, employee, officers, member, premises owner, affiliated organizations and insurers from legal liability due to any of their negligence or the negligence or actions of other riders, auditors, clinicians or spectators, (b) waive any legal claim I or my minor child or ward named below may have against the Mid-Ohio Dressage Association, its agents, volunteers, employees, officers, members, premises owners, affiliated organizations and Insurers for injuries resulting from any INHERENT RISKS OF EQUINE ACTIVITIES, as described above in Ohio Revised Code 2305.321, and (c) agree that I am participating in all equine activities hosted, organized or sponsored by Mid-Ohio Dressage Association at my own risk and assume all risk of damage or injury to my person, horse, or property other than that due to the intentional misconduct of the Mid-Ohio Dressage Association. I understand that this waiver will remain effective unless and until revoked by me in writing. I also agree that the Mid-Ohio Dressage Association or its agents may terminate any activity at their discretion in order to maintain a safe, professional and organized environment
